At the hearing, the parties will have the right to appear in person, or otherwise, and present supporting documentary evidence, and arguments in support of their respective positions. No later than at the hearing, each party shall provide three (3) hard copies of each document to be introduced into evidence. Any party to the proceedings has the right to appear at any conference, investigation or hearing in person, by counsel duly admitted to the Virgin Islands Bar or by other representative.

Any party who wishes to request a **postponement** of the hearing date **MUST DO SO** within ten (10) days of the issuance of this Notice. Otherwise the hearing date will be presumed to be acceptable, and later postponement requests, except for emergency or compelling circumstances, will not be granted.

Except for good cause shown, a **continuance** of the hearing shall not be granted unless application is made at least three (3) business days in advance.
